Resident Success Story: Asia Lykes

"When Your Destiny Meets Your Opportunity"









Asia Lykes was a single mom living in Henley Homes public housing community when it was designated for Hope VI redevelopment. As Henley Homes readied for demolition, Asia took advantage all the career development resources provided by Columbia Housing to aid in her relocation. "I got a Section 8 voucher and moved out of Public Housing. I went back to school to get my cosmetology license. The Housing Authority paid for childcare, cosmetology uniforms and transportation to and from class. Those opportunities and resources made a huge difference."

Asia says there was always something inside of her that wanted better. But it wasn't until she met Carrie Geiger & Katrina Bridgette at Columbia Housing that she began to see how to get it.

Asia recently returned to Columbia Housing to say "thank you" for the difference Mrs. Geiger and Mrs. Bridgette made in her life. By chance, Asia ran into Interim CEO Yvonda Bean in the agency parking lot and was excited to tell Mrs. Bean about her appreciation for all the agency did for her. "When I went back to cosmetology school, I met the man I was destined to marry. With our combined incomes, I no longer qualified for my Section 8 Voucher. I still remember how proud I was of myself when I gave my voucher back because I no longer needed it!". Mrs. Bean was elated to hear about Asia's successes and insisted she tell her story.

Today Asia is a licensed cosmetologist and Master Barber. She and her husband--a retired paramedic are currently building their new home on family-owned land in Swansea.

"I always knew I wanted better for myself and my family. Thank you Columbia Housing, Carrie Geiger and Katrina Bridgette for inspiring me, pushing me, supporting me, and helping me achieve my dreams. This is what it looks like when your destiny meets your opportunity," concludes Asia.

APPLY IN PERSON – June 6 thru June 13 at designated locations in Richland County.

HOW TO QUALIFY: You must be a low-income senior aged 60+, have a valid driver's license or state issued ID (must be presented to pick up), and live in Richland County.



Attention Richland County Seniors!

The Senior Farmer's Market Nutrition Program offering \$25 vouchers to low-income seniors living in Richland County starts June 6.

Seniors must qualify for the program to receive vouchers to buy fresh locally grown fruits and vegetables from authorized farmers this summer.

Seniors must apply in person June 6-June 13 at the designated locations listed in the graphic below. Please note the following:

- 1. The application is hard copy only and will be completed on the day of voucher distribution. Days, time and location are listed on the graphic.
- 2. WE WILL NOT complete the application prior to scheduled dates and time listed on the flyer.
