## **QUESTIONS AND ANSWERS**

1. What services are to be included in our 'Price Per Service' response?

Pricing should include the basic maintenance services including removal of debris; grass cutting; and trimming as needed. All other services will be requested on an as needed basis.

2. Do we have to bid every property in the RFP?

No, vendors may bid on any of the properties listed in the solicitation and do not have to bid on all properties. It is the intent of Columbia Housing to award more than one contract.

3. Is irrigation inspections included? If so, at what locations?

Irrigation inspections are part of the solicitation but are not part of the basic services. A separate task order will be issued to the selected vendor for each property where irrigation services are needed.

4. What locations have flower beds? Are replacement flowers included in our price at these locations?

Flower beds are to be maintained at the office and/or community building locations, not at residential locations.

5. Is mulch included in our price?

No, mulch is part of the solicitation but is not part of the basic services. A separate task order will be issued to the selected vendor for the each property where mulch services will be needed.

6. Is the main office, 1917 Harden Street, included in this RFP?

Yes, the main office at 1917 Harden Street is included in the solicitation. Please see list of locations.

7. Is 2133 Walker Soloman Way included in this RFP?

Yes, this location is the Resident and Family Service Center and it is included in this solicitation. Please see list of locations.

8. Are we expected to remove cigarette butts each visit?

Yes, we expect removal of all debris prior to any cutting which includes cigarette butts.

9. Are the properties at 1511 & 1515 McDuffie Ave. included in this RFP?

There are no locations on McDuffie Street included in the base services. Please see list of locations.

10. Do you have an address for Congaree Vista 2?

Please see list of locations. Congaree Vista 2 has an address of 602 Richland Street.

11. When you guys list the location for a Property, and it's listed as '2101-2113 Read Street' or 540-640 Superior Street', do we service every location (address) within that street range and all the common areas included in that street range?

The addresses provided are the City/USPS addresses. Services would be for all common areas at each address.

12. How often would do grass and properties need serviced?

Bids should be based on services provided every two weeks. Columbia Housing reserve the right to decrease or increase service timing based on weather conditions.

13. The grass grows very fast in certain of the year, dormant months we usually cut the grass every two weeks and in the spring time from March to September we do once a week.

14. How often is payment made?

Contractors are required to submit monthly invoice and payment is net 30 days from receipt of invoice.

15. Who do we report to if we have a problem or situation with one of the properties?

There will be a contract administrator assigned to the contract and that person will be your contact.

16. Are there set times that my company may begin working on the properties; ie. May we start at approximately 7 AM in the summertime?

Working hours would be reasonable hours so as to not disturb residents. Normally this would be 8:00 am – 6:00 pm. However, Columbia Housing is flexible in discussing working hours.

17. If we have any problems dealing with the environment, who do we report to?

18. Is the error and omissions and professional liability insurance required for lawn contract?

Yes, see insurance requirements set forth in the solicitation.
